This is a BOARDING CONTRACT between Canine & Company and the pet owner.

Canine & Company agrees to exercise due and reasonable care of their pet during exercise and group playtime and to keep the kennel premises sanitary and safe.

The dog(s) are to be fed properly and regularly, and to be housed in clean safe quarters. Feeding times are generally between 7-8 AM and 4-5 PM.

Medication is also administered at this time, unless given different/specific instructions by owner. All dogs are exercised in one of our several play areas and must be able to play in group social setting. It is at the discretion of Canine & Company how much and what type of exercise he/she will receive. If your dog is unable to be in a group social setting due to inappropriate or aggressive behavior he/she will receive one on one playtime up to three times daily with one of our camp counselors. This playtime may consist of walks, individual playtime in either an indoor or outdoor play area or they may receive cuddle time in one of our doggie suites. Dogs that are not able to join day care and require special handling will be assessed an additional daily fee of five (5) dollars per day _____ (Please initial.).

All dogs are boarded or are otherwise handled or cared for by Canine & Company staff with out liability on Canine & Company's part for loss or damage from disease, theft, fire, death, escape or injury to themselves or to person, other dog(s) or property by said dog(s), or for other unavoidable causes, due diligence and care having been exercised.

*Owner understands our daily rate as follows: _____ per day per pet. Rate is charged date to date; Regardless of drop off time or pickup time, any dog(s) requiring food provided through Canine & Company will be charged an additional two dollars (2) per pet per day. _____ (Please initial.).

All charges incurred by owner shall be payable upon pickup of pet(s). Owner further agrees pet(s) shall not leave until all charges have been paid.

It is further understood that during peak boarding times such as Thanksgiving, Christmas and Easter the owner may be required to give a 30% deposit of the total stay at the time of the reservation. This amount will not be refunded if the customer cancels without seven (7) days notice. However the deposit will be applied to the customers ending balance at the time of pickup _____ (Please initial.)

If the pet becomes ill or injured, Canine & Company, in its sole discretion, may engage the services of a veterinarian of its choosing, or administer medication, or give other requisite attention to the animal, and expenses there of shall be paid by owner _____ (Please initial.).

It is understood by Canine & Company and owner that all provisions of this contract shall be binding upon both parties there unto for this visit and all subsequent visits.

This is a DOG DAYCARE CONTRACT between Canine & Company and the pet owner.

Canine & Company agrees to exercise due and reasonable care, and to keep the daycare/kennel premises sanitary and properly enclosed.

All dogs are handled or cared for by Canine & Company's staff without liability on Canine & Company's part for loss or damage from disease, theft, fire, death, escape, injury or harm to persons, other dogs or property by said dog(s), or for other unavoidable causes, due diligence and care having been exercised.

All dogs must meet the following requirements (and show proof) for Dog Daycare:

For everyone's safety, dogs must be leashed at ALL TIMES upon entering or exiting the building and in the parking lot.

Any dog wearing a metal collar must be accompanied with a buckle collar. All collars must be properly fitted for safety, (we recommend Premier Collars) Please NO Rabies tags on collars; Must show proof of vaccinations (DHLPP, Bordetella, Rabies).

In addition, all dogs must be kept on a flea preventative during the months of April through October.. All dogs over seven months of age must be spayed or neutered. Lunches must be brought in a labeled, Ziploc baggie. All dogs must be dropped off and picked up through the front desk area. Do not bring a dog who has been coughing, vomiting, or has diarrhea. If your dog shows signs of an illness during the day, we will separate him/her from the other dogs, call and inform you (the owner) and keep the dog comfortable until you are able to pick him/her up. ~After 3 written warnings we will expel your dog from daycare for the safety of the other dogs and the staff. If your dog bites a person or another dog (without provocation) you will be called to pick up your dog. You are also responsible for the medical bills as a result of this injury. Examples of warnings that could be given: Snapping at, or biting dogs or people (playful nips not included)

Uncontrollable barking repeatedly jumping on staff members to the point of injuring the staff. Any dog not picked up by 6:00pm will be considered as a boarding dog and additional charges will apply as well as a \$10.00 late fee, unless arrangements were made prior to 6.00pm. Payment must be made in the same week of service. If payment is not made there will be an additional \$15.00 late fee applied.

If the pet becomes ill or injured, Canine & Company, in its sole discretion, may engage the services of a veterinarian of its choosing, or administer medication, or give other requisite attention to the animal, and expenses there of shall be paid by owner _____ (Please initial.).

It is understood by Canine & Company and Owner that all provisions of the Contract should be binding upon both parties thereunto for this visit and for all subsequent visits. This Contract contains the entire agreement between both parties.
